Re: Blue Springs Safety Storage South, LLC – Northeast quadrant of 167th Street and US 169 Highway – Request for amendment to Master ROI and Building 1 ROI.

Dear Shannon and Kevin:

The City Council of the City of Olathe, Kansas (“**Governing Body**”): (1) adopted Resolution No. 24-1045, authorizing the issuance of up to \$252,865,701 in one or more series of industrial revenue bonds for the benefit of Blue Springs Safety Storage South, LLC on its multi-site development at the northeast quadrant of 167th Street and US 169 Highway (“**Master ROI**”); (2) adopted Resolution No. 25-1030, authorizing the issuance of up to \$21,475,000 in industrial revenue bonds for the benefit of Blue Springs Safety Storage South, LLC for “Building 1” (“**Building 1 ROI**”); and (3) adopted Resolution No. 25-1099 revising its Industrial Revenue Bond and Property Tax Abatement Policy to allow property tax abatement of up to 80% for certain industrial projects (“**Revised IRB Policy**”).

Blue Springs Safety Storage South, LLC would like to formally request that the Governing Body consider an amendment to the Master ROI and Building 1 ROI to increase the abatement percentage to 80% pursuant to the Revised IRB Policy, and to address any accompanying changes necessary to any cost benefit analysis.

We respectfully request this amendment be considered by the Governing Body at the February 3, 2026, and February 17, 2026, meetings.
