AGREEMENT PURSUANT TO K.S.A. 12-2908 BETWEEN THE CITY OF OLATHE, KANSAS AND UNIFIED SCHOOL DISTRICT NO. 233, JOHNSON COUNTY, KANSAS PROVIDING SCHOOL RESOURCE OFFICERS FOR ACADEMIC YEAR 2025-2026

THIS AGREEMENT is entered into this 1st day of August, 2025 between the City of Olathe, a municipal corporation, hereinafter referred to as "City" and Unified School District No. 233, Johnson County, Kansas, a political subdivision of the State of Kansas, hereinafter referred to as "School District" (collectively "Parties" and each individually a "Party") as follows:

For and in consideration of the mutual promises, terms, covenants, and conditions set forth herein, the parties agree as follows:

1. Purpose of the Agreement.

- A. Each Party is a "municipality" as defined in K.S.A. 12-2908(a), and the Parties hereby agree that this Agreement is a contract for the performance by the City of a governmental service, activity, or undertaking which the City is authorized by law to perform.
- B. The purpose of this Agreement is to provide for the cooperation of the School District and the City in the planning, design and implementation of a School Resource Officer Program. This program will consist of assigning uniformed police officers, known as School Resource Officers (SROs) and associated equipment within the secondary schools. The SROs' responsibilities are to provide law enforcement at schools; provide a variety of educational opportunities to the school community; provide informal information and advice to students and parents; and provide a positive law enforcement presence in the school community. SROs will enforce infractions of both traffic and criminal law. SROs are not intended to serve as security personnel in the schools or to enforce school disciplinary policies.
- C. The Agreement is intended to provide SROs using a shared cost approach.
- D. The 2025-2026 academic year programs and services will have sixteen (16) full-time SROs and two (2) full-time supervisors who will be available for SRO services to the School District. SROs will be stationed at each secondary school facility. SRO services will be provided to those secondary schools on a daily basis. The Parties acknowledge and agree that there will be occasions when the SROs will not be available at each assigned secondary school due to training, illness, or other unforeseen personnel related issues. The five (5) high school SRO positions will be covered on all in-session days. The ten (10) middle schools and the District Alternative Learning Centers will be covered in like fashion with eleven (11) SROs who will be assigned based upon call load and activities.
- E. In the event this Agreement is automatically renewed for any additional twoyear periods, the Parties agree to discuss the estimated program costs and prepare and execute a mutually agreeable written amendment to the

Agreement to establish the services and funding for the next two-year period. The amendment will be substantially in the form of Exhibit A.

- 2. <u>Contractual Provisions</u>. The Provisions found in Contractual Provisions Attachment (Form DA-146a, Rev. 06-12), which is attached hereto, are hereby incorporated in this Agreement and made a part thereof as required by K.S.A. § 72-1148. (Exhibit B)
- 3. <u>Duration of Agreement</u>. This Agreement shall be effective August 1, 2025, and shall remain in effect until July 31, 2026, and, subject to Section 1.E., shall automatically renew for an additional two years unless notice of non-renewal or revision is given by either party before July 1, 2026. In accordance with K.S.A. 10-1101 et seq. (Cash-Basis Law), if, for whatever reason, adequate funding is not made available by City to support or justify continuation of the work under this Agreement, City may terminate or reduce the amount of work to be provided under this Agreement.
- 4. <u>Termination of Agreement and Notice</u>. This Agreement may be terminated without cause by either Party upon thirty (30) days prior written notice. Notice of termination must be provided in writing by both email and U.S. mail to the other Party as follows:

- 5. Relationship of the Parties. For the purposes of this Agreement, the relationship between the School District and the assigned police officers shall be that of an independent contractor. The police officers assigned to the School District are employees of the City and shall be subject to its sole control and supervision. The assigned officers will be subject to current procedures in effect for City's police officers, including attendance at all mandated training and testing to maintain state peace officer certification. This Agreement is not intended to and will not constitute, create, give rise to, or otherwise recognize a joint venture, partnership, or formal business association or organization of any kind between the parties, and the rights and obligations of the parties shall be only those expressly set forth in this Agreement. Further, the Parties agree that no person supplied by the School District to accomplish the goals of this Agreement is a City employee and that no rights under City retirement or personnel rules accrue to such person. The Parties agree that no person supplied by the City to accomplish the goals of this Agreement is a School District employee and that no rights under any School District retirement, personnel policies, or rules accrue to such person.
- 6. <u>Consideration</u>. In consideration for the assignment of SROs and supervisors to work with the School District as provided herein, the School District and the City agree to provide the following funding:
 - A. <u>City Fiscal Year 2025</u>: Total estimated program costs for sixteen (16) SROs and two (2) supervisors for the 2025-2026 school year is \$2,322,069.29. The 2025 estimated costs figure includes a police officer percent-based salary adjustment of four point three two percent (4.32%) or a four percent (4%) yearly lump sum adjustment. The Olathe Public Schools agrees to pay the

City of Olathe fifty percent (50%) of program costs for sixteen (16) SROs and two (2) supervisors, estimated at \$1,161,034.65. The City agrees to pay fifty percent (50%) of the program costs for sixteen (16) SROs and two (2) supervisors, estimated at \$1,161,034.65.

- B. SROs and supervisors will be called upon to perform after-hours activities. These occasions, including the security duties at specified school events, will be mutually agreed upon by the City's Police Department and the School District. These hours will be billed to the School District at a current rate of \$69.30 per hour worked. In return, the School District will reimburse the City for these occasions.
- 7. <u>Billing</u>. In the interest of working with two separate budget cycles, invoicing for the services provided during an academic year will occur twice per academic year. Each invoice will be for 25% of the total estimated program costs. The first invoice will be due by the end of December and the second and final invoice will be due by the end of May. Each Party must maintain for at least two (2) years the Party's records related to the services and expenditures related to this Agreement.

8. Responsibilities.

- A. The City shall be responsible for the following:
 - (1) Recruit, train, and assign certified law enforcement officers to serve in the schools.
 - (2) Appoint SROs, with such appointments to be made by the Chief of Police.
 - (3) Assign SROs to serve when school is in session, except on days an officer is absent due to illness or Police Department requirements approved by the Chief of Police or his or her designee.
 - (4) Evaluate each SRO through the School Resource Officer Unit Supervisors to ensure they are carrying out the duties outlined in Exhibit C. This evaluation is to include observation of SROs in the general school setting, as well as in the performance of general law enforcement duties and responsibilities.
 - (5) Provide a regular liaison with administrators in schools.
 - (6) Participate with the School District in annual evaluations of the School Resource Officer Program.
 - (7) Apply for and administer any grants to offset start up and annual operating costs of the School Resource Officer Program.
 - (8) Provide all police equipment, automobiles, uniforms, and law enforcement supplies, including computers for SROs to keep at the offices provided per Section 8(B)(6).

- B. The School District shall be responsible for the following:
 - (1) Participate with the City's Police Department in providing training for SROs through development of an orientation program and occasional inservice training opportunities.
 - (2) Evaluate each SRO's classroom presentations.
 - (3) Provide a regular liaison to coordinate the program with the City's Police Department.
 - (4) Participate with the City in annual evaluations of the School Resource Officer Program.
 - (5) Apply for and administer any grants to offset the annual operating costs of the School Resource Officer Program.
 - (6) Provide office space and basic supplies for each SRO.

Provide office space and basic office supplies for each SRO.

- 9. <u>Indemnification</u>. Subject to the Kansas Tort Claims Act, K.S.A. 75-6101 *et seq.*, City agrees to defend, indemnify and hold School District, its board members, agents, employees and volunteers harmless against and from any and all losses, claims, actions, damages, expenses or liabilities, including reasonable attorney's fees, arising out of or in any way connected with City's negligent performance of this Agreement, including negligent or other wrongful acts by SROs. City assumes worker's compensation liability for injury or death of the SROs and other City employees provided to the School District pursuant to this Agreement
- 10. <u>No Third-Party Beneficiary</u>. This Agreement, including, but not limited to, the indemnification provision in Paragraph 9, is for the benefit of the parties only and does not create, nor is it intended to create, any benefit or liability to third parties.
- 11. <u>Miscellaneous</u>. SROs and supervisors shall comply with all applicable federal, state and city laws and ordinances, as well as School District policies, in the performance of their duties under this Agreement.

- 1. <u>Terms Herein Controlling Provisions</u>: It is expressly agreed that the terms of each and every provision in this attachment shall prevail and control over the terms of any other conflicting provision in any other document relating to and a part of the contract in which this attachment is incorporated. Any terms that conflict or could be interpreted to conflict with this attachment are nullified.
- 2. **Kansas Law and Venue**: This contract shall be subject to, governed by, and construed according to the laws of the State of Kansas, and jurisdiction and venue of any suit in connection with this contract shall reside only in courts located in the State of Kansas.
- 3. Termination Due To Lack Of Funding Appropriation: If, in the judgment of the Director of Accounts and Reports, Department of Administration, sufficient funds are not appropriated to continue the function performed in this agreement and for the payment of the charges hereunder, State may terminate this agreement at the end of its current fiscal year. State agrees to give written notice of termination to contractor at least thirty (30) days prior to the end of its current fiscal year and shall give such notice for a greater period prior to the end of such fiscal year as may be provided in this contract, except that such notice shall not be required prior to ninety (90) days before the end of such fiscal year. Contractor shall have the right, at the end of such fiscal year, to take possession of any equipment provided State under the contract. State will pay to the contractor all regular contractual payments incurred through the end of such fiscal year, plus contractual charges incidental to the return of any such equipment. Upon termination of the agreement by State, title to any such equipment shall revert to contractor at the end of the State's current fiscal year. The termination of the contract pursuant to this paragraph shall not cause any penalty to be charged to the agency or the contractor.
- 4. <u>Disclaimer Of Liability</u>: No provision of this contract will be given effect that attempts to require the State of Kansas or its agencies to defend, hold harmless, or indemnify any contractor or third party for any acts or omissions. The liability of the State of Kansas is defined under the Kansas Tort Claims Act (K.S.A. 75-6101, *et seq.*).
- 5. Anti-Discrimination Clause: The contractor agrees: (a) to comply with the Kansas Act Against Discrimination (K.S.A. 44-1001, et seq.) and the Kansas Age Discrimination in Employment Act (K.S.A. 44-1111, et seq.) and the applicable provisions of the Americans With Disabilities Act (42 U.S.C. 12101, et seq.) (ADA), and Kansas Executive Order No. 19-02, and to not discriminate against any person because of race, color, gender, sexual orientation, gender identity or expression, religion, national origin, ancestry, age, military or veteran status, disability status, marital or family status, genetic information, or political affiliation that is unrelated to the person's ability to reasonably perform the duties of a particular job or position; (b) to include in all solicitations or advertisements for employees, the phrase "equal opportunity employer"; (c) to

comply with the reporting requirements set out at K.S.A. 44-1031 and K.S.A. 44-1116; (d) to include those provisions in every subcontract or purchase order so that they are binding upon such subcontractor or vendor; (e) that a failure to comply with the reporting requirements of (c) above or if the contractor is found guilty of any violation of such acts by the Kansas Human Rights Commission, such violation shall constitute a breach of contract and the contract may be cancelled, terminated or suspended, in whole or in part, by the contracting state agency or the Kansas Department of Administration; (f) Contractor agrees to comply with all applicable state and federal anti-discrimination laws and regulations; (g) Contractor agrees all hiring must be on the basis of individual merit and qualifications, and discrimination or harassment of persons for the reasons stated above is prohibited; and (h) if is determined that the contractor has violated the provisions of any portion of this paragraph, such violation shall constitute a breach of contract and the contract may be canceled, terminated, or suspended, in whole or in part, by the contracting state agency or the Kansas Department of Administration.

- 6. <u>Acceptance of Contract</u>: This contract shall not be considered accepted, approved or otherwise effective until the statutorily required approvals and certifications have been given.
- 7. Arbitration, Damages, Warranties: Notwithstanding any language to the contrary, no interpretation of this contract shall find that the State or its agencies have agreed to binding arbitration, or the payment of damages or penalties. Further, the State of Kansas and its agencies do not agree to pay attorney fees, costs, or late payment charges beyond those available under the Kansas Prompt Payment Act (K.S.A. 75-6403), and no provision will be given effect that attempts to exclude, modify, disclaim or otherwise attempt to limit any damages available to the State of Kansas or its agencies at law, including but not limited to, the implied warranties of merchantability and fitness for a particular purpose.
- 8. Representative's Authority to Contract: By signing this contract, the representative of the contractor thereby represents that such person is duly authorized by the contractor to execute this contract on behalf of the contractor and that the contractor agrees to be bound by the provisions thereof.
- <u>Responsibility for Taxes</u>: The State of Kansas and its agencies shall not be responsible for, nor indemnify a contractor for, any federal, state or local taxes which may be imposed or levied upon the subject matter of this contract.
- 10. <u>Insurance</u>: The State of Kansas and its agencies shall not be required to purchase any insurance against loss or damage to property or any other subject matter relating to this contract, nor shall this contract require them to establish a "self-insurance" fund to protect against any such loss or damage. Subject to the provisions of the Kansas Tort Claims Act (K.S.A. 75-6101, *et seq.*), the contractor shall bear the risk of any loss or damage to any property in which the contractor holds title
- 11. <u>Information</u>: No provision of this contract shall be construed as limiting the Legislative Division of Post Audit from having access to information pursuant to K.S.A. 46-1101, et seq.
- 12. The Eleventh Amendment: "The Eleventh Amendment is an inherent and incumbent protection with the State of Kansas and need not be reserved, but prudence requires the State to reiterate that nothing related to this contract shall be deemed a waiver of the Eleventh Amendment."
- 13. Campaign Contributions / Lobbying: Funds provided through a grant award or contract shall not be given or received in exchange for the making of a campaign contribution. No part of the funds provided through this contract shall be used to influence or attempt to influence an officer or employee of any State of Kansas agency or a member of the Legislature regarding any pending legislation or the awarding, extension, continuation, renewal, amendment or modification of any government contract, grant, loan, or cooperative agreement.

EXHIBIT C

The School Resource Officer Will:

- 1. Work hours either from 7:15a-3:15p (high schools) or 7:45a-3:45p (middle schools) Monday through Friday; (40 hrs/wk)
- 2. Provide law enforcement and police services to the school, school grounds and areas adjacent to the school. Investigate allegations of criminal incidents per police department policies and procedures. Enforce state and local laws and ordinances.
- **3.** Make appropriate referrals to juvenile authorities or other governmental agencies.
- **4.** Patrol the school grounds, ensuring overall safety, viewing videos and security monitors, and watching for strangers or suspicious activity.
- **5.** Establish and maintain a close partnership with school administrators in order to provide for a safe school environment.
- **6.** Assist school officials with their efforts to enforce policies and procedures.
- 7. Assist school administrators in emergency crisis planning and building security matters.
- **8.** Provide a course of training for school personnel in handling crisis situations, which may arise at the school.
- 9. Be visible within the school community. Attend and participate in school functions. Build working relationships with the school's staff as well as with student and community groups.
- **10.** Supervising special events and directing foot and auto traffic if necessary.
- 11. Giving small group or assembly presentations on school safety, drug and alcohol abuse, bullying, and online safety.
- **12.** Protect the school and students against theft and property damage and assisting in medical emergencies.
- 13. Work with guidance counselors and support staff to assist students when referrals to service agencies are necessary, or to assist in conflict resolutions.
- 14. Initiate interaction with students in the classroom and general areas of the school building. Promote the profession of police officer and be a positive role model. Increase the visibility and accessibility of police to the school community.
