## ORDINANCE NO. 25-08

AN ORDINANCE ANNEXING CERTAIN LANDS TO THE CITY OF OLATHE, KANSAS, IN CONFORMITY WITH THE PROVISIONS OF K.S.A. 12-520(a)(7), AND AMENDMENTS THERETO.

**WHEREAS**, the Governing Body of the City of Olathe, Kansas, has received a petition from the owner of the following described real property requesting that such property be annexed to the City of Olathe, Kansas (ANX25-0001):
