AGREEMENT RENEWAL

This Agreement Renewal ("Renewal") made this _____ day of _____, 2025, by and between the City of Olathe ("City") and GSC Lighting & Supply ("Vendor") (collectively, the "Parties").

WHEREAS, the City and Vendor have previously entered into an Agreement, dated September 4, 2024 ("the Agreement"), for streetlight supplies; and

WHEREAS, the Agreement was for a term of one (1) year;

WHEREAS, Section 1 of the Agreement provides that the Agreement may be renewed for up to four (4) additional one (1)-year periods upon the written agreement of both parties; and

WHEREAS, the Agreement will currently expire on September 4, 2025; and

WHEREAS, the Parties are desirous of renewing the Agreement..

- A. The Agreement is hereby modified as follows: pricing has been updated as set forth in **Exhibit A**; and
- B. The Agreement, as modified, is hereby renewed for an additional term of one (1) year, commencing at the expiration of the current term on September 4, 2025.

IN ALL OTHER RESPECTS, the terms and conditions of the Agreement will remain in full force and effect, except as specifically modified by any prior written renewals approved by the Parties and by this Renewal, including all policies of insurance which will cover the work authorized by this Renewal.
