

SEVENTH ADDENDUM TO PROFESSIONAL SERVICES AGREEMENT

This Seventh Addendum to Professional Services Agreement (the “Addendum”), dated as of the last signature below (the “Effective Date”), is made by and between City of Olathe, Kansas (“Client”), and Marathon Health, LLC (“Marathon”). Client and Marathon may be referred to individually as a “Party” and jointly as the “Parties.”

RECITALS

WHEREAS, Client and Marathon are parties to that certain Professional Services Agreement dated as of June 11, 2015, for certain preventive, wellness, disease management, health consultation and primary care services, as amended from time to time (as amended, the “Agreement”); and

WHEREAS, the Parties wish to amend the Agreement to expand the scope of Professional Services to be provided by Marathon to Client;

NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which is hereby acknowledged, and intending to be legally bound, the Parties agree as follows:

1. **Expansion of scope of Professional Services.** Commencing July 1, 2026, Marathon will provide the following additional Professional Services to Client:
 - a. Specialty Care Consultation. Marathon’s Care Providers will have access to virtual consultations with third-party medical specialists for consultation on conditions where the opinion of a specialized medical provider is clinically appropriate. If appropriate, the Care Providers will work with the specialists to create care plans guided by the specialist medical consultants.
 - b. Patient Support Call Center. Centralized patient support call center for Patient appointment scheduling, responding to questions, incentive information, service escalations and other patient support during regular Health Center operating hours.
2. **Fees.** The Parties agree that these services are being provided at no charge to Client and there has been no change in Fees as a result of this expansion of scope.
3. **Restatement of Staffing.** The Parties agree that there has been no change to staffing levels set forth in Schedule A and they remain as follows:

Staffing*	FTE
Nurse Practitioners/Physician Assistants	1.0
Medical Assistants	1.0
Behavioral Health Counselor	0.8
Physical Therapist	0.6

* The Marathon staffing model also assumes that each mid-level practitioner will have a Collaborating Physician who provides medical supervision, consultation, chart review, and quality assurance activities.

4. Extension of Term.

- a. Term Extension. Pursuant to the terms of the Fifth Addendum to the Agreement, Client hereby exercises its option to renew the Agreement for an additional term of one (1) year following the conclusion of the current term, which is set to conclude December 31, 2026. The renewal term shall commence January 1, 2027 and continue through December 31, 2027 (the "Renewal Term").
- b. Fees for Term Extension. The current Annual Service Fee and PT Cost shall automatically increase by 5% effective January 1, 2027 and on each January 1st in the event of a subsequent renewal of the Agreement.

5. **Miscellaneous.** This Addendum is made under and incorporates the terms and conditions of the Agreement. The terms and conditions set forth in this Addendum are in addition to and not in substitution of any terms or conditions set forth in the Addendum.. Capitalized terms not otherwise defined in this Addendum. shall have the meanings ascribed to them in the Agreement. Except as specifically modified by this Amendment, the terms and conditions of the Agreement remain in full force and effect.
