**Description:** This project will improve Black Bob Road from 153<sup>rd</sup> Terrace to 159<sup>th</sup> Street from a 2-lane roadway to a 4-lane divided arterial section. Improvements will include pavement construction, curb and gutter, medians, streetlights, sidewalk and sidepath and storm sewers.

**Justification:** This project is needed to address safety and capacity concerns in the area. This project has been identified as a near term priority project in the Transportation Master Plan.
