Zoning verification is a service provided to verify the zoning and permitted uses of a property. A standard letter can verify the allowance of a particular use on a property, approved development standards and zoning violations. An expedited letter provides a rush delivery within 3 business days. This fee is proposed to cover the cost of providing this service and is based on comparable rates in neighboring jurisdictions.



Solid Waste Service Charges are based on the Cost Allocation Model and Solid Waste Rate Model. Infrastructure is proposing a 5.0% rate increase in 2026 on the residential fee structure. This will increase the residential fee from \$21.66/month to \$22.74/month. The residential fee structure includes curbside recycling and yard waste service as part of the base residential rate. The predominant cost drivers for the increase are fuel, disposal, and vehicle replacement costs.



Infrastructure is proposing a 5% increase in 2026 on residential and non-residential fees. For nonresidential uses, a base rate is multiplied by an area factor, so the non-residential fee will be raised according to lot size sq/ft.

Currently, ownership of those meter pits, rings, vaults etc. are not in our specs. These meters are charged the sewer base charge in addition to usage, but their water meters are only charged water rates, so we are technically not recovering base costs for double metered properties like we would for the standard single meter setup. Adding this fee could be a double benefit of recovering costs and more formally confirming that we do own the maintenance of these second meters.

As new connections are added to the City's water and sewer systems, System Development Fees (SDF) are charged to recover the cost of providing system capacity to the new connection. SDF rates are based on the Cost Allocation Model and Water & Sewer Rate Model. Infrastructure is proposing raising water and sewer SDF 5% in 2026 to help offset the costs of increased capacity. The fiscal impact on a new single-family residence will increase from \$5,970 to \$6,269 for sewer. For meter sizes not listed, a formula is provided.


