



### OLATHE LANDSCAPE CALCULATIONS

#### Street Trees (Per UDO 18.30.130.G)

Required: 1 tree / 40' street frontage, excluding arterial and minor arterial streets where perimeter landscaping is required

Provided: Shadow Ridge Drive: 437 LF / 40 = 11 Trees

Lot 1: 171 LF / 40 = 4 Trees

Lot 4: 106 LF / 40 = 3 Trees

Lot 5: 160 LF / 40 = 4 Trees

Private Drive: 125 LF / 40 = 3 Trees

Lot 1: 200 LF / 40 = 5 Trees

Lot 3: 252 LF / 40 = 6 Trees

Lot 4: 66 LF / 40 = 2 Trees

#### Landscaping along Arterial/Collector Streets (Per UDO 18.30.130.H)

Required: Along property zoned R-1 through R-4 adjacent to an arterial street  
Provided: N/A

#### Screening (Per UDO 18.30.130.I)

Required: All exterior-mounted equipment and trash screened from public view  
Provided: As required

#### Buffer (Per UDO 18.30.130.J)

Required: Type 1: 10' width buffer = 1 shade, 1 ornamental, 1 evergreen, + 20 shrubs / 100'  
Provided: Type 1 buffer:  
Lot 2 along east PL: 234 LF = 2 shade, 2 ornamental, 2 evergreen, 47 shrubs

### Nonresidential Landscaping (Per UDO 18.30.130.L)

Applicability: Where a street separates a nonresidential use from property zoned or designated on the Comprehensive Plan Map for nonresidential use

Required: 10' width; 1 shade or evg tree / 50' street frontage + 1 ornamental / 3 trees

Provided: Shadow Ridge Drive:

Lot 1: 171 LF / 50 = 3 Trees + 1 ornamental

Lot 4: 106 LF / 50 = 2 Trees + 1 ornamental

Lot 5: 160 LF / 50 = 3 Trees + 1 ornamental

Private Drive:

Lot 1: 297 LF / 50 = 6 Trees + 2 ornamental

Lot 3: 252 LF / 50 = 5 Trees + 2 ornamental

Lot 4: 66 LF / 50 = 1 Trees + 1 ornamental

W Valley Parkway:

Lot 2: 273 LF / 50 = 6 Trees + 2 ornamental

Lot 3: 222 LF / 50 = 3 Trees + 1 ornamental

Lot 4: 402 LF / 50 = 8 Trees + 3 ornamentals

K-10 Highway:

Lot 1: 945 LF / 50 = 19 Trees + 6 ornamentals

Lot 6: 338 LF / 50 = 7 Trees + 2 ornamentals

### Parking & Vehicular Use Areas: Interior (Per UDO 18.30.130.M.3)

Required: 1 island / 20 parking spaces; 1 shade tree / island; landscape aisles & strips min. 10' width (20' width with pedestrian walkway); 1 tree / 30' landscape aisle/strip

Provided: Lot 1: 291 Stalls / 20 = 15 Trees

Lot 2: 8 Stalls / 20 = 1 Tree

Lot 3: 12 Stalls / 20 = 1 Tree

Lot 4: 42 Stalls / 20 = 2 Trees

Lot 5: 12 Stalls / 20 = 1 Tree

Lot 6: 34 Stalls / 20 = 2 Trees

### Building Facade/Foundation Landscaping (Per UDO 18.30.130.O)

Applicability: Nonresidential developments. Does not apply to building facades abutting a sidewalk or the rear yard. Building facades adjacent to public ROW or a paved area.

Required: Landscape area equivalent to 25% building facade with 75% plant coverage, shrubs must be 3' ht.; deciduous & ornamental trees incorporated where appropriate. Planting areas must have a minimum width of either six (6) feet or the equivalent of twenty (20) percent of the building facade height as measured from the ground elevation to the top of the wall or parapet, whichever is greater.

Provided: As required

### LANDSCAPE NOTES


- LOCATE UTILITIES PRIOR TO COMMENCING LANDSCAPE OPERATIONS. ALL TREES SHALL BE FIELD POSITIONED AS TO AVOID CONFLICTS WITH EXISTING AND PROPOSED UTILITIES. NOTIFY LANDSCAPE ARCHITECT OF ANY CONFLICTS OR OBSTRUCTIONS.
- CONTRACTOR SHALL STAKE ALL PLANTING AREAS IN THE FIELD PRIOR TO PLANTING FOR APPROVAL OF THE OWNER OR THEIR REPRESENTATIVE.
- QUANTITIES SHOWN ARE FOR REFERENCE ONLY. CONTRACTOR SHALL VERIFY ALL PLANT QUANTITIES PRIOR TO BIDDING AND SHALL BE RESPONSIBLE FOR ALL QUANTITIES FOR THEIR BID. ANY DISCREPANCIES WITH THE PLAN SHALL BE BROUGHT TO THE ATTENTION OF THE LANDSCAPE ARCHITECT. THE PLAN QUANTITIES SHALL SUPERCEDE SCHEDULED QUANTITIES.
- PLANT SYMBOLS ON LANDSCAPE PLAN ARE SHOWN AT FULL MATURE SIZE. ACTUAL PLANT SIZES AT INSTALLATION MAY BE SMALLER AND SHALL BE THE MINIMUM PLANTING SIZE SPECIFIED IN PLANT SCHEDULE.
- ALL PLANT MATERIALS SHALL BE SPECIMEN QUALITY AND SHALL COMPLY WITH RECOMMENDATIONS AND REQUIREMENTS OF ANSI Z60.1 THE 'AMERICAN STANDARD FOR NURSERY STOCK.'
- ALL PLANTING BEDS & NATIVE GRASS STANDS SHALL BE EDGED AS SHOWN IN PLAN.
- PREPARE PLANTING BEDS AND INCORPORATE AMENDMENTS ACCORDING TO PLANS.
- SHREDDED HARDWOOD MULCH, PER SPECIFICATIONS SHALL BE USED AS A THREE INCH (3") TOP DRESSING IN ALL PLANTING BEDS AND AROUND ALL TREES. SINGLE TREES AND SHRUBS SHALL BE MULCHED TO THE OUTSIDE EDGE OF THE SAUCER OR LANDSCAPE ISLAND.
- ALL TREES SHALL BE STAKED PER DETAIL.
- ALL PLANT MATERIALS SHALL BE INSTALLED TO ALLOW A ONE FOOT (1') CLEARANCE BETWEEN PLANT AND ADJACENT PAVEMENT.
- THE LANDSCAPE CONTRACTOR SHALL NOT COMMENCE WORK UNTIL THE SITE IS FREE OF DEBRIS CAUSED BY ON-GOING CONSTRUCTION OPERATIONS. REMOVAL OF DEBRIS SHALL BE THE RESPONSIBILITY OF THE GENERAL CONTRACTOR. LANDSCAPE WORK SHALL NOT BEGIN UNTIL THE LANDSCAPE ARCHITECT AND OWNER HAVE GIVEN WRITTEN APPROVAL FOR SUCH. THERE SHALL BE NO DELAYS DUE TO LACK OF COORDINATION FOR THIS ACTIVITY.
- THE LANDSCAPE ARCHITECT AND OWNER SHALL APPROVE GRADES AND CONDITION OF SITE PRIOR TO SODDING/SEEDING OPERATIONS.
- ALL AREAS DISTURBED DURING CONSTRUCTION AND NOT DESIGNATED FOR OTHER PLANTINGS OR Hardscape SHALL BE SODDED WITH TURF TYPE FESCUE.
- ALL LANDSCAPE AREAS SHALL BE IRRIGATED. TURF AREAS SHALL BE IRRIGATED BY SPRAY OR ROTOR. PLANT BEDS SHALL BE IRRIGATED BY DRIP IRRIGATION. IRRIGATION SYSTEM SHALL INCLUDE AUTOMATIC RAIN-SENSOR DEVICE. IRRIGATION SHOP DRAWINGS SHALL BE PROVIDED BY THE CONTRACTOR FOR APPROVAL PRIOR TO CONSTRUCTION.
- ALL DECORATIVE GRAVEL SHALL BE INSTALLED OVER GEOTEXTILE FABRIC (MIRAFI 140N OR APPROVED EQUAL).

IN THE EVENT OF WORK IN OR ON THE JCW SANITARY MAIN, ANY TREES OR PLANTINGS PLACED WITHIN THE SEWER EASEMENT MAY BE REMOVED WITHOUT REPLACEMENT OR COMPENSATION THEREOF AND SHALL BE REPLACED BY THE PROPERTY OWNER AS REQUIRED BY THE CITY.




NOTES:

### SEED TO SOD TRANSITION DETAIL




NOTES:  
1. SET ALL EDGING 1" ABOVE FINISH GRADE AS SHOWN.  
2. EDGING SHALL ABUT ALL CONCRETE CURBS AND WALKS PERPENDICULAR AND FLUSH WITH TOP OF CONCRETE.  
3. ALL JOINTS SHALL BE SECURELY STAKED.  
4. CONTRACTOR SHALL CUT TOP EDGES AS NEEDED TO BE PARALLEL WITH GRADE.  
5. ALL GRAVEL SHALL BE INSTALLED OVER A GEOTEXTILE FABRIC (MIRAFI 140N OR APPROVED EQUAL).  
6. GRAVEL SHALL BE APPROVED BY OWNER PRIOR TO INSTALLATION. FILTER FABRIC SHALL NOT BE VISIBLE AFTER GRAVEL INSTALLATION.

### MOW EDGE DETAIL - NTS




NOTES:  
1. EDGING PER SPECIFICATIONS. SET ALL EDGING 1" ABOVE FINISH GRADE (TURF) SURFACE AS SHOWN.  
2. EDGING SHALL ABUT ALL CONCRETE CURBS AND WALKS PERPENDICULAR AND FLUSH WITH TOP OF CONCRETE.  
3. ALL JOINTS SHALL BE SECURELY STAKED.  
4. FINISH SHALL BE POWDER COAT COLOR: GREEN. CONTRACTOR SHALL SUBMIT COLOR SAMPLE TO OWNERS REPRESENTATIVE PRIOR TO APPROVAL.  
5. CONTRACTOR SHALL LOCATE AND MARK ALL PLANT BED LOCATIONS PRIOR TO INSTALLATION OF STEEL FOR FINAL APPROVAL BY OWNER OR LANDSCAPE ARCHITECT.




### V-CUT NATURAL EDGE DETAIL - NTS



NOTES:  
1. REFER TO SPECIFICATIONS FOR TOPSOIL BACKFILL MIX.  
2. CONTRACTOR TO WATER THOROUGHLY AFTER PLANTING.  
3. INSTALLATION TO BE IN ACCORDANCE WITH PLANTING SPECIFICATIONS.  
4. WHERE ADJACENT TO CURB, MAINTAIN THE MINIMUM OFFSET SHOWN. FOR SHRUBS LARGER THAN 4" MATURE DIAMETER, PROVIDE A GREATER OFFSET EQUAL TO 1/2 OF THE MATURE DIAMETER MINIMUM.
