

RESOLUTION NO. 26-1060

A RESOLUTION APPOINTING MEMBERS TO THE STREET MAINTENANCE SALES TAX (SMST) FINANCE OVERSIGHT COMMITTEE.

WHEREAS, on November 12, 2013, the voters of Olathe approved the implementation of a 10-year 3/8 percent street maintenance sales tax for the purpose of financing the cost of repairing, rebuilding, rehabilitating, upgrading and improving streets in the City of Olathe, and the voters of Olathe approved the renewal of the tax on April 25, 2023; and

WHEREAS, the Street Maintenance Sales Tax (SMST) Finance Oversight Committee was created by Ordinance No. 25-1054 to be an advisory body tasked with the review of the 3/8 cent sales tax-related revenues and expenditures during the ten-year term of the tax, April 2024 - March 2034; and

WHEREAS, the Committee consists of seven (7) members appointed for two (2) year staggered terms; and

WHEREAS, current members and terms are as follows:
