

## RESOLUTION NO. 25-1061

### A RESOLUTION APPOINTING A MEMBER TO THE MAHAFFIE STAGECOACH STOP AND FARM ADVISORY BOARD.

**WHEREAS**, the Governing Body has established the Mahaffie Stagecoach Stop and Farm Advisory Board as described in Olathe Municipal Code Chapter 2.64; and

**WHEREAS**, in 2003, the Governing Body created the Mahaffie Stagecoach Stop and Farm Foundation by adopting Articles of Incorporation and Bylaws, with said Bylaws having been amended by the Governing Body in 2011; and

**WHEREAS**, the Foundation is organized and operated for the benefit of and to assist the functions and purposes of the Mahaffie Stagecoach Stop and Farm in Olathe; and

**WHEREAS**, pursuant to the Foundation Articles of Incorporation and Bylaws, the Olathe City Council appoints a Foundation board of trustees, which governs the business and affairs of the Foundation consistent with the Articles of Incorporation and Bylaws; and

**WHEREAS**, the Governing Body on February 1, 2022, which, among other things, assigned the Advisory Board the duty of acting as the Foundation board of trustees, and set the Advisory Board membership to be no less than nine (9) and no more thirteen (13) members; and

**WHEREAS**, the Advisory Board now consists of no less than nine (9) and no more than thirteen (13) members appointed for four-year staggered terms; and

**WHEREAS**, current members and terms of the Board are as follows:
