AGREEMENT RENEWAL

This Agreement Renewal ("Renewal") made this _____ day of _____, 2025, by and between the City of Olathe ("City") and Traffic Control Corp. ("Vendor") (collectively, the "Parties").

WHEREAS, the City and Vendor have previously entered into an Agreement, dated July 19, 2022 ("the Agreement"), for traffic signal supplies; and

WHEREAS, the Agreement was for a term of one (1) year;

WHEREAS, Section 1 of the Agreement provides that the Agreement may be renewed for additional one (1)-year periods upon the written agreement of both parties; and

WHEREAS, the Parties have previously renewed the Agreement once; and

WHEREAS, the Agreement will currently expire on July 18, 2025; and

WHEREAS, the Parties are desirous of renewing the Agreement.

NOW THEREFORE, the Parties hereby agree as follows:

- A. The Agreement is hereby modified as follows: updated pricing outlined in Exhibit A and
- B. The Agreement, as modified, is hereby renewed for an additional term of one (1) year, commencing at the expiration of the current term on July 18, 2025.
- C. The Agreement, as modified, allows for pricing adjustments (either up or down) based on market conditions. Vendor must provide written justification for the change.

IN ALL OTHER RESPECTS, the terms and conditions of the Agreement will remain in full force and effect, except as specifically modified by any prior written renewals approved by the Parties and by this Renewal, including all policies of insurance which will cover the work authorized by this Renewal.

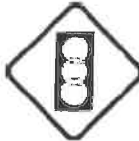
