# SUPPLEMENTAL AGREEMENT NO. 1 FOR PROFESSIONAL SERVICES City of Olathe, Kansas

This Supplemental Agreement made this \_\_\_\_\_ day of \_\_\_\_\_, 2024, by and between the City of Olathe ("City") and HNTB Corporation ("Consultant") (collectively, the "Parties").

WHEREAS, the City and Consultant have previously entered into an Agreement, dated June 21, 2023 ("the Agreement"), to furnish Professional Services for the combined Ridgeview Road Arterial Mill and Overlay Project (165th Street to 159th Street, Project No. 3-P-002-24), Sheridan Street Arterial Mill & Overlay Project (Dennis Avenue to Mur-Len Road, Project No. 3-P-003-24), and Santa Fe Street Arterial Mill & Overlay Project (I-35 Highway to Mur-Len Road, Project No. 3-P-004-24) ("Project"); and

WHEREAS, Section II.B.2 of the Agreement provides that Consultant will provide, with City's concurrence, services in addition to those listed in the Agreement when such services are requested or authorized in writing by the City; and

WHEREAS, this Supplemental Agreement between the Parties is to provide additional Professional Services in the way of **Final Design and Construction Phase Services** (HNTB Project Number 83361-DS-001) for the Project as outlined in **Exhibit A** of this Supplemental Agreement, attached hereto and incorporated herein by reference; and

WHEREAS, the City is desirous of entering into this Supplemental Agreement to pay the Consultant for additional services rendered to the City related to the Project; and

WHEREAS, the City is authorized and empowered to contract with the Consultant for the necessary additional services in this Supplemental Agreement.

NOW THEREFORE, the Parties hereby agree as follows:

- A. The Agreement is hereby amended as follows: The scope of services now includes Exhibit A of this Supplemental Agreement.
- B. The total fee for the additional professional services provided pursuant to this Supplemental Agreement is \$68,375, which raises the total fee for all services provided under the Agreement from \$352,015 to \$420,390.

IN ALL OTHER RESPECTS, the terms and conditions of the Agreement will remain in full force and effect, except as specifically modified by any prior written Supplemental Agreement approved by the Parties and by this Supplemental Agreement, including all policies of insurance which will cover the work authorized by this Supplemental Agreement.



# **Description of Project & Map**

# <u>2024 Street Preservation Projects Arterial Mill & Overlay (3-P-002-24 & 3-P-003-24 & 3-P-004-24)</u> Supplemental Agreement No. 1 for Final Design Services

This scope of services outlined below and detailed in the Fee Estimate (attached) is based upon the additional Final Design services requested by the City of Olathe as it relates to the 2024 Street Preservation Mill & Overlay Project. The services are necessary to construct a shared use path along Mur-Len Road and add additional lighting and plantings along the Mid-America Nazarene University (MNU) not included in the original scope of services.



The specific services requested for the Sheridan Street (Dennis Avenue to Mur-Len Road) project are described as follows:

- Provide preliminary cost estimate for shared use path, lighting, and landscaping improvements along MNU for Sheridan Street (fronting MNU) and Mur-Len Road (from Sheridan to Pioneer Way).
   Preliminary cost estimate will be conceptual and utilized to refine the limits of shared use path to be installed which was later determined to be Pioneer Way.
- Obtain survey at entrances necessary for shared use path design (see subconsultant KVE scope)
- Prepare final design and details for shared use path along Mur-Len Road (Sheridan Street to Pioneer Way) including details and profiles for entrance reconstruction, retaining wall modification / reconstruction.
- Prepare final design and details for pedestrian lighting along Sheridan Street (fronting MNU) and Mur-Len Road (Sheridan Street to Pioneer Way). Lighting will supplement existing City / Evergy lighting to provide illumination of the shared use path and will not be designed to vehicular standards. Lighting fixtures and poles will not be City standards but will be as specified by MNU. A new lighting controller

will be included as it is assumed the City will own and maintain the lights.

- Include landscaping (trees) in the plans fronting MNU. Tree species and general layout will be as
  provided by MNU. HNTB will confirm utility conflicts with tree placement, add trees installation to plans
  and specifications, and incorporate bid items into the construction cost estimate. Landscaping design
  of tree and planting layout is not included.
- Create new and Revise right-of-way documents (obtain O&E documents, prepare color tract maps, legal descriptions, and front-end documents) fronting MNU. Assumes 3 total easement documents (2 separate Sidewalk and Utility Easements from Sheridan to Pioneer Way and one Street and Utility Easement).
- Additional Utility Coordination for Shared Use Path along Mur-Len Road

### Schedule:

- Draft plans for improvements fronting MNU will be provided by January 12, 2023 or at least three weeks following notice-to-proceed.
- Final Bid Plans (overall original set including additional work fronting MNU) to be provided by January 26, 2024, or at least two weeks from final comments from City and MNU.
- Right-of-way documents to be provided by January 19, 2024

# Assumptions:

- Retaining wall detail will be City standard for Sidewalk with Abutting Retaining Wall. Assumed retaining wall height does not exceed 2'.
- Any relocation of City fiber will be in advance of project and HNTB is not responsible for design.
- MNU improvements to be included in overall Sheridan / Santa Fe bid plan set and not a separate bid plan set.

# ADDITIONAL SCOPE OF SERVICES

The following scope of services shall be governed by the previously submitted Subconsultant Quality Plan Cover Sheet:

- 1. Existing project control shall be extended as deemed necessary by KVE Professional Surveyor to encompass the additional survey areas. Any such control shall be an addendum to the control point table referred to in TASK 2 (vii).
- 2. Additional topographic survey area is **outlined in red on attached Exhibit D**. Survey shall conform to the requirements of TASK 3 of the Agreement.
- 3. Additional surface location of utilities as **outlined in brown on attached Exhibit D**. The surface locations shall conform to the requirements of TASK 3 (iv) (a), (b), (c) and (d).
- 4. Where sanitary and/or storm structures are encountered in the areas **outlined in brown on attached Exhibit D**, only the surface location and elevation shall be reported.
- 5. Three (3) easements/takings (one revision and two additional) will be created by KVE. This effort shall conform to the requirements of TASK 6 of the Agreement.


