# CITY OF OLATHE AGREEMENT RENEWAL

This Agreement Renewal ("Renewal") made this 18<sup>th</sup> day of October, 2023, by and between the City of Olathe ("City") and GSC Lighting and Supply, Inc. ("Vendor") (collectively, the "Parties").

WHEREAS, the City and Consultant have previously entered into an Agreement, dated June 22, 2022 ("the Agreement"), for streetlight poles and bases; and

WHEREAS, the Agreement was for a one (1) year;

WHEREAS, Section 1 of the Agreement provides that the Agreement may be renewed for up to four (4) additional one(1) year periods upon the written agreement of both parties; and

WHEREAS, the Parties have not previously renewed the Agreement;

WHEREAS, the Agreement will currently expire on June 30, 2023; and

WHEREAS, the Parties are desirous of renewing the Agreement.

NOW THEREFORE, the Parties hereby agree as follows:

The Agreement, as modified, is hereby renewed for an additional term of one (1) year, commencing at the expiration of the current term on June 30, 2023. The City agrees to pay an amount not to exceed \$150,000.00 for the contract period.

IN ALL OTHER RESPECTS, the terms and conditions of the Agreement will remain in full force and effect, except as specifically modified by any prior written renewals approved by the Parties and by this Renewal, including all policies of insurance which will cover the work authorized by this Renewal.
