

## RESOLUTION NO. 19-1020

### **A RESOLUTION REAPPOINTING MEMBERS TO THE STREET MAINTENANCE SALES TAX (SMST) FINANCE OVERSIGHT COMMITTEE.**

WHEREAS, the Street Maintenance Sales Tax Finance Oversight Committee was created by Resolution No. 14-1020 on February 18, 2014; and

WHEREAS, the purpose of the Committee is to review and report on revenues and expenditures related to the 10-year, 3/8-cent street maintenance sales tax approved by Olathe citizens on November 12, 2013; and

WHEREAS, the Committee consists of seven (7) members appointed for two (2) year staggered terms; and
