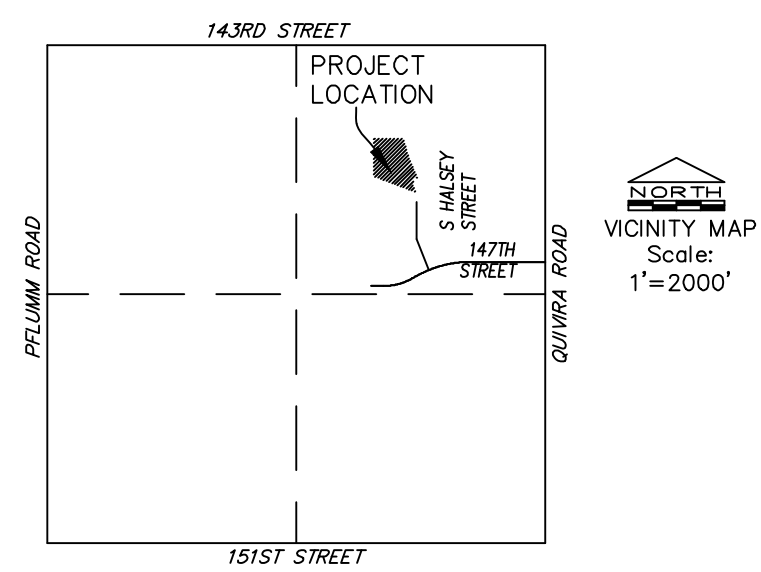


FINAL PLAT OF

LEGAL DESCRIPTIONS:

This is a Resurvey and Replat of Lots 2 and 3, GREYSTONE LAKE, a subdivision in the City of Olathe, Johnson County, Kansas containing 2.02 acres.

The undersigned proprietors of the above tracts of land has caused the same to be subdivided in the manner shown on the accompanying plat, which subdivision and plat shall hereafter be known as "Fuller's Greystone Lake".

DEDICATION:

The undersigned proprietors of the above described tracts of land hereby agree and consent that the Board of County Commissioners of Johnson County, Kansas, and the City of Olathe, Johnson County, Kansas, shall have the power to release such land proposed to be dedicated for public ways and thoroughfares, or parts thereof, for public use, from the lien and effect of any special assessments, and that the amount of unpaid special assessments on such land dedicated, shall remain a lien on the remainder of this land fronting and abutting on said dedicated public way or thoroughfare.

CONSENT TO LEVY:

The undersigned proprietors of the above described tracts of land hereby agree and consent that the Board of County Commissioners of Johnson County, Kansas, and the City of Olathe, Johnson County, Kansas, shall have the power to release such land proposed to be dedicated for public ways and thoroughfares, or parts thereof, for public use, from the lien and effect of any special assessment, and that the amount of unpaid special assessments on such land so dedicated, shall become and remain a lien on the remainder of this land fronting or abutting on such dedicated public way or thoroughfare.

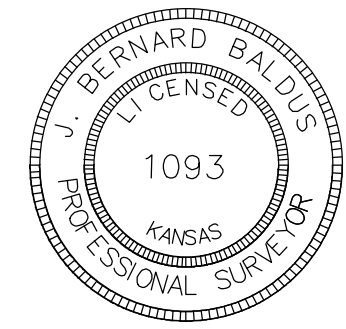
