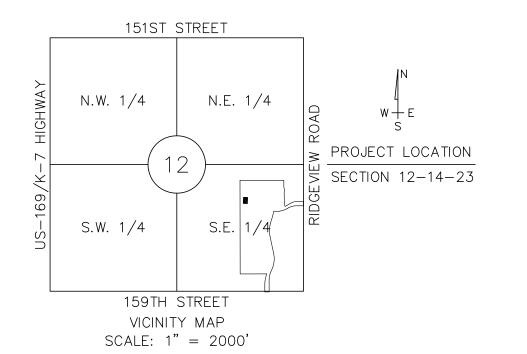

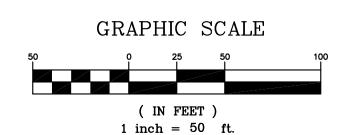

2. INTERIOR LOT LINES FOLLOW CENTERLINES OF PARTY WALLS AND THEIR EXTENSIONS.

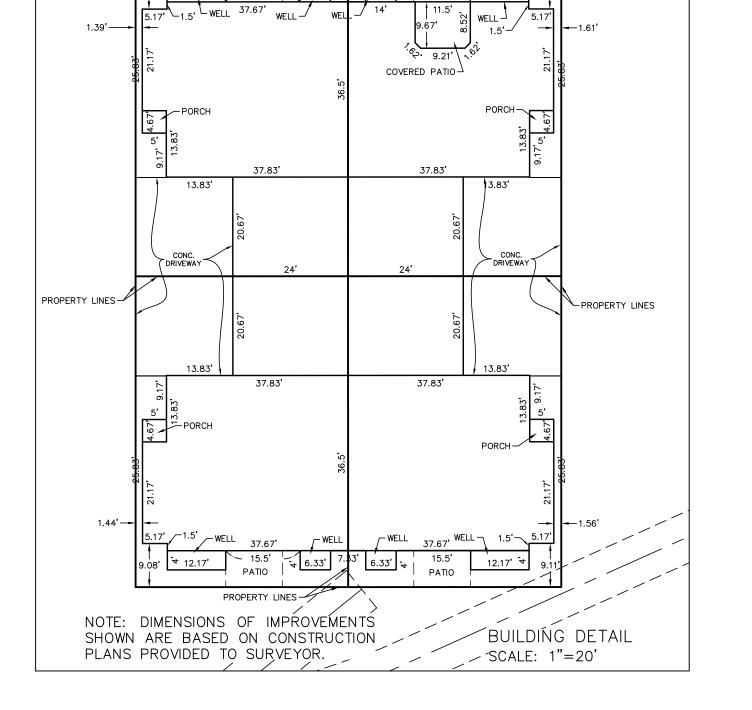
