WITNESSETH:

WHEREAS, the City and Consultant have previously entered into an Agreement, dated September 17th, 2019 ("the Agreement"), for the WTP2: Electrical Modifications and Improvements Project, PN 5-C-028-20 and WTP: Chemical Feed Modifications Project, PN 5-C-026-20, hereinafter referred to as the "Project"; and

WHEREAS, SECTION II, Paragraph B of the Agreement provides that Consultant will provide, with City's concurrence, services in addition to those listed in the Professional Services Agreement, when such services are requested or authorized in writing by the City.

WHEREAS, this Supplemental Agreement No. 1 between the parties heretofore is to provide Design and Bidding phase services for the Project as outlined in **Exhibit B** of this Supplemental Agreement No. 1, attached hereto and incorporated herein by reference; and

WHEREAS, the City is desirous of entering into Supplemental Agreement No. 1 to pay the Consultant for additional services rendered to the City related to the Project; and

WHEREAS, the City is authorized and empowered to contract with the Consultant for the necessary additional professional services under the Agreement, and necessary funds for the payment of said services related to the Project are available and authorized under the Agreement.

NOW THEREFORE, the parties hereby agree as follows:

- A. Exhibit B of the Agreement is hereby amended as follows: Add scope of services as outlined in Exhibit A of this Supplemental Agreement No. 1.
- B. The total fee for the aforementioned additional professional services provided pursuant to this Supplemental Agreement No. is \$1,220,027 which raises the total fee for all services provided under the Agreement from \$107,910 to \$1,327,937.

IN ALL OTHER RESPECTS, the terms and conditions of the Agreement will remain in full force and effect, except as specifically modified by this Supplemental Agreement No. 1, including all policies of insurance which will cover the work authorized by this Supplemental Agreement No. 1.

EXHIBIT A Description of Project & Map

The Water Treatment Plant No. 2 (WTP2) Electrical Modifications and Improvements project includes detailed design phase services for the City of Olathe. Reliable electrical power, communications, and chemical feed systems are critical to the production and distribution at any water treatment facility. The utility and standby power systems at the Olathe WTP2 and associated collector wells are inefficient in providing the reliable power needed. WTP2 was originally constructed in the 1960s. The facilities, including utilities and standby power, have been added over multiple projects. The result of these expansions has yielded electrical systems, which are complex and counterintuitive. The capacity of the electrical system and its respective arrangement is not suitable for the City to grow its production capabilities.

Furthermore, standby power is insufficient to back up the water production needs and is limited in its distribution on the plant site by an aged distribution system. This project will include design and bid phase services to implement the recommended improvements in the Olathe WTP2 Electrical Modification Technical Memorandum (5-C-028-20), briefly summarized below:

- WTP2 Redundant Power Primary and Secondary utility feeds while reusing the existing WTP2 standby generator in case of a large-scale utility outage.
- WTP2 Power Distribution A complete medium voltage loop around the WTP with step down transformers.
- Horizontal Collector Well Redundant Power Horizontal Collector Wells 1, 3, and 4 will be provided with local redundant power by having a dedicated standby generator at each of the wells. In addition, a new automatic transfer switch (ATS) and an elevated concrete structure will be provided at each collector well.
- SCADA Improvements Replace all SLC5/05 PLCs, install a fiber network loop, expand the existing control room in the membrane building, and upgrade the SCADA software.
- Chemical Feed Improvements Various chemical feed improvements including completing the plant chemical ductbank loop, replacing and relocating the fluoride feed system, membrane building chemical storage improvements, ammonia system improvements, and sanitary sewer improvements.

Below is a map of the WTP2 project site.



EXHIBIT B

Scope of Services

This scope describes engineering services the Consultant will provide the City in connection with the WTP2: Electrical Modifications project (5-C-028-20) and Chemical Feed Modifications project (5-C-026-20). The description of work is included in Exhibit A and includes the following phases. Phases I through III shall be performed as defined below. Upon completion, Phase IV will be defined and provided as a supplemental service.

PHASE I. PROJECT ADMINISTRATION AND DESIGN MEMORANDUM

PHASE II. DETAILED DESIGN

PHASE III. BIDDING PHASE SERVICES

PHASE IV. CONSTRUCTION PHASE SERVICES (Supplemental)

PHASE I. PROJECT ADMINISTRATION AND DESIGN MEMORANDUM

- 1. Project Administration ~ Provide administration and management of project. Prepare project management documents including budget, schedule, drafting standards manual, and quality assurance and quality control plan. Review progress with City on a regular basis and discuss issues with the City as they are noted. The anticipated duration of the project is fourteen (14) months from kickoff through Phase III Bidding Phase Services.
 - a. Project Initiation- Conduct a project initiation meeting to clarify City's requirements for the project, review pertinent available data, review project staffing and organization, present initial work plan, and present initial work schedule.
 - b. Monthly Project Updates Submit a one-page status report with monthly invoices to appraise the City on progress of the work. The report will include such items as:
 - i. Status of work done on major tasks
 - ii. Project budget update
 - iii. Project schedule update
 - c. Prepare preliminary design memorandum which summarizes the background data for the project, establishes the design criteria and requirements for sizing of equipment, and provides preliminary layout for any new facilities. Prior to submittal of the final memorandum, an independent internal quality control review will be performed to ensure conformance with established project requirements.
 - i. The design memorandum will include the following information relative to design procedures and facility layout.

- 1. General project scope and background references.
- 2. Schematics and Process Flow Diagrams
- 3. Spatial layouts of new facilities and/or equipment
- 4. Discipline design standards
- ii. Submit two (2) hard copies and one (1) electronic copy of the design memo for City review.
- iii. Conduct a meeting with City staff and Consultant to discuss any City staff comments. Revise documents if necessary and submit two (2) copies to City as record of decisions at the design memorandum phase.
- iv. Once accepted by the City, Consultant will submit to KDHE on behalf of the City and coordinate and review comments.

PHASE IL DETAILED DESIGN

- Front-End Documents Utilize City's front-end documents, EJCDC general conditions, special conditions, standard specifications and standard details for both Construction and Procurement documents. Meet with City to resolve review comments and revise Consultant's standard documents accordingly.
- 2. Detailed Design Detailed design is to commence only after City has accepted design criteria and the Basis of Design Memorandum. Aspects of final design related to the design memorandum will not proceed until a final decision has been made on those items. The construction contract documents shall be prepared for selection of a Contractor on a competitive bid basis. Three (3) design packages will be submitted to the City for review at the 60%, and 90% design levels for review and input. The submitted design packages will serve as milestones wherein certain features shall be fixed after a period of Owner review. Changes made after fixing features will be considered Supplemental Services. Opinions of probable construction cost will be provided at the review meetings for the 60% and 90% design levels.
- 3. Scope of Work The following describes the scope of improvement proposed for the Electrical / Backup Power project.
 - a. Redundant & Reliable Power Supply
 - i. Installation of a second utility feed to the plant.
 - ii. Modifications to existing utility service.
 - iii. Testing, repair and maintenance of the existing 2,000 kW standby generator. Repairs to include replacing the battery charger and ceiling fan, topping off the coolant, any other improvement required to reuse the generator.

- iv. Installation of a new medium voltage switchgear with outdoor enclosure.
- v. Installation of seven (7) new 12470-480 V step-down transformers.
- vi. Installation of two (2) new 480 V switchboards.
- vii. Future 2,500 kW generator
- viii. Miscellaneous equipment and controls
- ix. Generator and switchgear equipment pads and associated sitework
- x. Coordination with on-site utility service provider (Evergy), as needed to provide redundant and reliable power.

b. Effective Power Distribution

- i. Approximately 2,500 feet of medium voltage power distribution loop with several step-down transformers. The loop will include excavation, backfill, duct banks, PVC conduits, cable and fiber.
- ii. Connection of existing plant loads to the new step-down transformers and/ or switchboards.

c. Collector Well Standby Power

- i. Testing, repair and maintenance associated with reusing the existing 1,500 kW standby generator at Collector Well No. 1.
- ii. Inspection, testing, repair and maintenance associated with reusing the existing 480 V MCCs at Collector Well Nos. 1, 3 and 4.
- iii. Replacement of the existing service entrance rated ATS at Collector Well No. 1.
- iv. Installation of two new 650 kW generators at Collector Wells Nos. 3 and 4.
- v. Installation of two new service entrance rated ATS at Collector Wells Nos. 3 and 4.
- vi. Connect each ATS to utility power and the associated generator.
- vii. Connect each ATS to its respective collector well MCC.
- viii. Construction of an oversized elevated concrete structure for each collector well generator and ATS.

d. SCADA Upgrades for Existing Plant

- i. Scope for the SCADA Upgrades is based on the City of Olathe preselecting a SCADA system integrator. The design for SCADA upgrades will include a control block diagram, fiber details, SCADA location plans and specifications. P&IDs, control descriptions, I/O lists and panel enclosure details will not be provided.
- ii. Replace 15 existing SLC5/05 PLCs with Allen-Bradley ControlLogix PLCs.
- iii. Backpanel replacement for existing PLC Enclosures.
- iv. Convert existing PLC programs from RSLogix500 to Studio5000.

- v. Upgrade Wonderware InTouch HMI software to Wonderware System Platform.
- vi. Install new fiber network loop as part of the power distribution loop.
- vii. Install new SCADA computer, server and network hardware
- viii. Install new reporting software
- ix. Develop new HMI Standards.
- x. Develop new System Platform HMI Application to meet standards.

e. Instrumentation and Control Coordination

- i. Provide detailed design for instrumentation, monitoring and control for new electrical and chemical feed system improvements. This will include P&IDs, specifications, instrument schedules, I/O schedules, installation details and panel details as required.
- ii. Facilitate four 4-hour workshops with pre-selected system integrator to develop SCADA System HMI, PLC and tagging standards.
- iii. Expand the Membrane Building Control Room to the East. Expansion will add approximately 240 square feet. Walls will be CMU construction, with heating and air conditioning with a packaged split DX AC System.

f. Chemical Feed Coordination

- i. Complete the chemical duct bank loop around the site.
- ii. Demo and replace the existing fluoride system. New system will be relocated to the Chlorine Building.
- iii. Chemical storage improvements in the Membrane building. Improvements include:
 - 1. Repurposing the existing Membrane Building Ferrous Chloride Bulk storage area for citric acid bulk storage.
 - 2. Adding two bulk ferrous chloride storage tanks to the east of the membrane building, located outside with heat tracing. Ferrous chloride improvements would also include reworking the feed pumps and piping.
 - 3. Polymer system containment improvements including expansion of the containment area, a new protective liner system, and a new scale with built in containment.
 - 4. Addition of an eyewash station on the north side of the Membrane Building. Emergency eyewash station will be provided with tepid water connection.
- iv. Improvements to the ammonia system including adding containment, cleaning and repainting the old tank piping, inspection of the tank interior and coatings, and adding an additional tank to provide redundancy.
- v. Replacement of the existing sanitary sewer piping and pumps to allow for

off-site pumping.

4. Permitting – Submit plans and specifications to KDHE for approval of the design improvements. The 90% plans will be marked "Final – KDHE Review Set" and submitted for review.

PHASE III. BIDDING PHASE SERVICES

- 1. Document Distribution Provide five (5) sets of construction contract drawings and specifications and one electronic pdf set to the City for advertisement of the Contract and distribution by the City.
- 2. Prebid Conference Conduct a prebid conference at City's facility to:
 - a. Confirm the types of information required by the contract documents and the format in which bids should be presented.
 - b. Review special project requirements and contract documents in general.
 - c. Prepare minutes of conference and issue to plan holders.
- 3. Interpretation of Bidding Documents and Addenda Preparation Interpret bidding documents and respond to bidder inquiries. Prepare and issue addenda to the construction contract documents when required.
- 4. Distribute four (4) sets of the construction contract documents to the successful bidder.

SUPPLEMENTAL SERVICES

- 1. Any work requested by City that is not included in one of the tasks listed herein will be classified as Supplemental Services.
- 2. Construction Phase Services.
- 3. Any meetings with local, State, or Federal agencies, or other affected parties to discuss the project, other than those specifically noted.
- 4. Appearances at any public hearings or before special boards other than those specifically noted.
- 5. Special consultants or independent professional associates requested or authorized by the City.

6. Additional progress review meetings or meetings with other City departments for coordination purposes.

CITY'S RESPONSIBILITIES

The City will furnish, as required by the work and not at the expense of the Consultant, the following items:

- 1. Drawings and reports that are available in the files of the City and which may be useful in the work involved under this contract.
- 2. The services of at least one of the City's employees or staff who has the right of entry to, and who has knowledge of, the existing water treatment plant facilities.
- 3. Appoint an individual who shall be authorized to act on behalf of City, with whom Consultant may consult at all reasonable times, and whose instructions, requests, and decisions will be binding upon City as to all matters pertaining to this Agreement and the performance of the parties hereunder.

EXHIBIT D CITY OF OLATHE INSURANCE REQUIREMENTS

- **A**. Consultant shall procure, and maintain as required, insurance against claims for injuries to persons or damages to property which may arise from or in connection with the project. The cost of such insurance shall be included in the Consultant's bid.
- **B**. Consultant shall maintain the following coverages and minimum limits.
 - 1. Commercial General Liability (CGL): [ISO "occurrence" form or its equivalent] \$1,000,000 per occurrence limit including personal and advertising injury and products completed operations. Any general aggregate limit should be at least \$2,000,000.
 - 2. Business Auto Coverage: (Owned and non-owned autos) \$500,000 per occurrence, combined single limit.
 - 3. Workers Compensation and Employers Liability: Workers compensation limits as required by applicable state workers' compensation laws and employer's liability limits or equivalent of \$500.000/\$500.000/\$500.000.
 - 4. Professional Liability: Minimum limits to be \$1,000,000 each claim / annual aggregate.
 - 5. Coverage Limits. Coverage limits for General and Auto Liability exposures may be met by a combination of primary and umbrella policy limits.
 - 6. Exposure Limits: The above are minimum acceptable coverage limits and do not infer or place a limit on the liability of the Consultant nor has the City assessed the risk that may be applicable to Consultant. Consultant shall assess its own risks and if it deems appropriate and/or prudent maintain higher limits and/or broader coverages. - **E.** Cancellation. Each insurance policy required shall not be suspended, voided, or canceled, except after Consultant has provided thirty (30) days' advance written notice to the City.
- F. Sub-Consultants. All coverages for sub-Consultants must meet all of the requirements stated herein.
