### ITEM DESCRIPTION:

Consideration of Engineer’s Estimate, acceptance of bids and award of contract to Phoenix Concrete, LLC for construction of the Heatherstone and Bradford Falls Local and Collector Street Mill and Overlay Project, PN 3-P-008-19.

### SUMMARY:

On February 20, 2019, five (5) bids were received and opened for the above referenced project. The bids ranged from \$2,568,413.01 to \$2,676,365.90 with the Engineer’s Estimate at \$2,885,170.50. Phoenix Concrete, LLC submitted the low and responsible bid in the amount of \$2,568,413.01. The following is a tabulation of the bids received:

This Street Preservation project will provide a 2” depth mill and asphalt overlay, spot replacement of concrete curb and sidewalk, installation of ADA sidewalk ramps and replacement of pavement markings on sixty-three (63) local and collector streets generally in the Heatherstone and Bradford Falls neighborhoods (see attached Project Location Map).

Construction is scheduled to begin in Spring 2019 and will be completed in Fall 2019.
