ITEM DESCRIPTION:

Consideration of Engineer's Estimate, acceptance of bids and award of contract to VF Anderson Builders, LLC for construction of the Troost Street Improvements Project, PN 3-R-002-21.

SUMMARY:

On January 19, 2021, eight (8) bids were received and opened for the above referenced project. The bids ranged from \$860,629.00 to \$1,104,200.60 with the Engineer's Estimate at \$1,071,153.00. VF Anderson Builders, LLC submitted the low and responsible bid in the amount of \$860,629.00. The following is a tabulation of the bids received:

This Street Reconstruction project on Troost Street, between Park Street and Wabash Street, will include full depth asphalt pavement and subgrade replacement, replacement of concrete curb and

gutters, replacement of sidewalk, driveway approaches, streetlight installation and stormwater improvements.

Construction is tentatively scheduled to begin in late Spring 2021 and tentatively scheduled to be completed in Fall 2021.
