### ITEM DESCRIPTION:

Consideration of Resolution No. 21-1024 authorizing the public sale of Water and Sewer System Improvement and Refunding Revenue Bonds, Series 2021.

### SUMMARY:

Gilmore & Bell, the City's bond counsel, has prepared Resolution No. 21-1024 authorizing the sale of Water and Sewer System Revenue Bonds, Series 2021 in the approximate amount of \$38,300,000.00 This proposed revenue bond issuance will provide funding for the following projects and refund a portion of Series 2010C.

Project expenditures funded by this bond issue total \$10,481,400.00. The remaining amount of issuance covers refunding Series 2010C in the amount of \$26,990,918.75 and \$3,071,921.25 covers debt service requirements related to debt service reserve fund and costs of issuance. Revenue bonds are secured by future user fee revenues, rather than the City's ability to levy taxes.

Series 2021 has a 20-year term, with the last bonds of the series maturing in 2041. The refunded portion for Series 2010C has a 15-year term with a maturity date of 2036. The bond sale is set for Tuesday, May 4, 2021. A tabulation of bids and recommendation of award will be presented at the City Council meeting on the same date.
